## **Top Story for the Week:**

## EW: Raising FV estimate to Php31.80/sh on 1Q17 earnings beat

We are raising our net income forecast and FV estimate on EW following its better-than-expected performance in the first quarter. Recall that the bank's 1Q17 income jumped 54% y/y to Php1.2Bil, exceeding both COL and consensus estimates. The outperformance was driven by strong net interest and fee-based revenues as well as lower-than-expected provisioning. Overall, we are raising our net income forecasts by 4% in 2017 and by 14% in 2018. We are also upgrading our FV estimate on EW by 14% to Php31.80/sh, based on 1.25X 2017E P/BV.

#### **Market Summary:**

The PSEi advanced during the week on the back of strong foreign buying. The benchmark index gained 82.58 points or 1.03% to close at 7,990.24. Value turnover decreased to Php44.5Bil from Php57.3Bil the previous week. Foreigners were net buyers throughout the week, accumulating Php3.7Bil worth of shares.
